	Provide a chart of current group structure, including any wholly or partly owned subsidiaries.	
1.2	<b>Details of companies carrying on the business</b>	
	Provide the following details in relation to each company in the group:	
	(a) any registered business names under which the company does business;	
	(b) any domain names which are registered to a group company, or used by a group company in carrying on its business; and	
	(c) copies of any constituent documents.	
1.3	<b>Details of authorised and issued capital</b>	
	Provide details of issued capital of each company in the group and specifically:	
	(a) confirm what securities have been issued by each company;	
	(b) provide details of the rights attaching to each class of shares and other securities; and

	(c) provide a list of shareholders of each company and details of shares or other securities held.	
1.4	<b>Agreement for issue of shares or other securities</b>	
	Confirm the existence of and provide any agreements, arrangements or understanding in force or securities issued which require the present or future issue of, or grant to any person the right to require the issue of any shares or securities in any group company	
1.5	<b>Statutory registers</b>	
	Provide statutory registers, books and records of each company.	
2.	<b>ASSETS</b>	
2.1	<b>Identify all material relevant assets of the businesses by reference to the type of asset, location, condition, use and market value. These assets will include:</b>	
	(a) land and buildings (whether owned or leased);

	Please provide the terms of any employee share or option plan.	
6.4	<b>Schedule of employees</b>	
	Please provide a schedule of the total number of employees of the group companies, including total per annum wage or salary costs for each employee.	
6.5	<b>Consultants</b>	
	Please provide copies of agreements for any consultants or other persons (other than employees) who provide key services to the businesses.

7.1	<b>Details of superannuation and pension funds</b>

	Provide details of and any documents relating to litigation, prosecutions, arbitrations, disputes and claims actual, pending or threatened in relation to any group company, including any industrial relations clause.

	Confirm whether there are any facts or circumstances likely to give rise to any such litigation, prosecutions, arbitrations, disputes and claims in relation to the businesses.

8.4	<b>Claims and contingencies</b>	
	Provide information regarding the following:	
	(a) any material contingent liabilities and material claims; and	
	(b) any violation of any employee safety and environmental laws.	
8.5	<b>Product warranty materials</b>	
	Provide a history of warranty claims for products produced by the group companies, if any.	
9.	<b>RELATED PARTY TRANSACTIONS</b>	
	Provide details of any agreement, arrangement or understanding, whether current or proposed, in relation to the group companies and the following parties:	
	(a) any related bodies corporate; or	
	(b) any director or proposed director of the company or its related bodies corporate, their immediate family or any firm, or any company or other entity in which such a person has an interest or directorship.

11.	<b>GOVERNMENTAL AND REGULATORY INFORMATION</b>	
11.1	<b>Government approvals</b>	
	Provide a list of any governmental approvals, permits, certificates, registrations, concessions, exemptions, etc, required in order for the companies to conduct their business in every jurisdiction in which group companies do business (including as the same may relate to import/export matters).	
11.2	<b>Government filings and orders</b>	
	Provide any material filings with, or enquiries, information requests, reports, administrative orders, notices of violation of complaints from, any foreign, federal, state or local governmental or regulatory authority.
