



Off-licence

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

67/OFF/50/2019

Pursuant to the Sale and Supply of Alcohol Act 2012, **The Gate Limited**, is authorised to sell alcohol on the premises situated at 6 Barry Ave, Cromwell and known as The Gate, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day.
- b) Alcohol may be sold or delivered only on the following days and during the following hours:
From the bottle store or across the bar - Monday to Sunday 7.00am to 11.00pm
- c) Alcohol may only be delivered Monday to Sunday between the hours of 6.00am and 11.00pm.
- d) Each of the following parts of the premises is designated as a supervised area: **Every bar and any bottle store**
- e) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- f) A copy of this licence must be displayed at the principal entrance to the premises.

Duration


Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- Until the close of the period for which it was last renewed; or
- If an application for the renewal of the licence is duly made before the licence would otherwise expire until the close of the period 3 years after the period for which it was last renewed.

Expiry date being **22 December 2022** unless renewed for a further period.
