Conditions

- 2. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday, 9.00am to 9.00pm

- 3. The licensed area is the whole of the interior of the premises.
- 4. The whole of the sales area, the walk-in chiller and the office are designated as supervised.
- 5. A copy of the licence must be displayed at each principal entrance.
- 6. Signs must be displayed at every point of sale detailing the statutory restriction on the sale and supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- 7. In the case of remote sales the licensee must ensure that the requirements of section 59 of the Act are met at all times.
- **8.** Drinking water must be freely available to customers, while alcohol is being supplied free as a sample on the premises.
- 9. There shall be no external advertising of alcohol products and prices on the outside of the building.
- 10. There shall be no single sales of beverages including mainstream beer, RTD's and shots (except in vessels over 500ml and craft beer).

This licence is described as an off-licence (Bottlestore) and the fee payable was \$816.50

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force

- 1. Either
 - i. Until the close of the period for which it was last renewed; or
 - ii. If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- If an application for the renewal of the licence is duly made before the licence would otherwise expire, either
 - i. Until the close of the period of 3 years after the period for which it was last renewed; or
 - ii. If it has never been renewed, until the close of the period of 4 years after the day it was issued.



DECISION

This is an application by SRAN LIQUOR HOLDINGS LIMITED for the renewal of an Off-Licence number 27/OFF/12973/2022, in respect of premises situated at 3 Potae Avenue, Gisborne known as "Super Liquor Lytton".

The application was duly notified and no matters in opposition to the application have been raised from any reporting agency and no objections have been lodged. Accordingly, pursuant to s.191 (2) of the Act, the matter is considered on the papers by the committee commissioner.

I am satisfied as to the matters to which the committee must have regard as set out in sections 105, 106 and 131 of the Act and I grant the applicant an off-licence renewal authorising the continued sale and supply of alcohol, for consumption off the premises.

PREMISES DESCRIPTION / BACKGROUND:

- Hospitality Licensing Limited on behalf of Sran Liquor Holdings has made application (Appendix 1) to the Gisborne District Licensing Committee for the renewal of an Offlicence (Bottlestore) under Section 127 of the Sale and Supply of Alcohol Act 2012 (the Act), to sell alcohol for consumption off the premises situated at 3 Potae Avenue, Gisborne, and known as Super Liquor Lytton.
- 2. This is the first renewal by the applicant, Hospitality Licensing Limited on behalf of Sran Liquor Holdings (Appendix 2), who took over the underlying licence 27/OFF/10271/2017 on 9 March 2022. Prior to this the applicant was granted a Temporary Authority Order on 9 March 2022 while the new licence application was being processed as the underlying licence expired on 29 April 2023. The new off-licence was issued as 27/OFF/12973/2022 on 18 May 2022.
- 3. The premises has been licensed as an Off-licence Bottlestore since 1994. Most recently Liquor King Lytton West from 2004 and previously Lytton West Liquor Store from 1994. Resource consents PD94003 14 February 1994, PD94079A 5 December 1994, and PD94079B 1 November 2001, were granted to permit the operation of licensed premises and to extend the hours of operation to 9:00am to 11:00pm Monday to Sunday. The introduction of the Gisborne District Local Alcohol Policy on 5 March 2018 overrules these consented hours and reduced them to 9:00am to 9:00pm.
- **4.** The applicant leases the building and associated grounds from the property owner, BJ Moss Limited, who has given permission for the applicant to hold an alcohol licence in a letter dated 18 February 2022 (Appendix 3).
- 5. No variation to the conditions of the existing licence are sought for this renewal. No changes to the building or layout have been made during the renewal period.

6. In terms of the fee category the licensed premises has been assessed as an Off-licence Bottlestore and has been assigned a medium fee category which means the applicant has paid \$816.50 for the application and will be charged an annual fee of \$632.50.

LOCATION OF THE PREMISES:

- 7. The premises are situated on land zoned Suburban Commercial under the operative Tairawhiti Resource Management Plan (the Plan).




Figure 1. Location Map

- 8. The premises are accessed from Potae Avenue which is a small suburban feeder road running between Lytton Road and Nelson Road. Please find attached a location map as Figure 1.

- **9.** The surrounding locality includes land zoned as General Residential, Recreation Reserve, Neighbourhood Reserve, and Rural Residential.
- 10. Neighbouring activities and uses within the immediate vicinity include a small local shopping mall adjacent to the premise which includes retail businesses as well as commercial businesses in the vicinity. Hauora Tairawhiti is approximately 150 away on Ormond Road, OneSchool Global are 120 metres and Lytton High School is approximately 190 metres from the premise on Lytton Road. In the wider vicinity there are further commercial and retail businesses, residential dwellings, industrial businesses agricultural activity.
- 11. The premises is located near a temporary liquor ban area, approximately 100 metres away at the Lytton West Reserve. The temporary ban is in place from 8:00am 27 December to 6:00pm 1 January each year during the Rhythm & Vines Festival.

PLANNING AND BUILDING MATTERS

12. Pursuant to Section 127 (2) (e) of the Act, the application is accompanied by a statement by the applicant that because of the building's current use, its owner is not required to provide and maintain a fire evacuation scheme (Appendix 4).

NOTIFICATION:

- 13. Pursuant to Section 101(b) of the Act and Section 36 to 38 of the Sale and Supply of Alcohol Regulations 2013 (the Regulations) the application was publicly notified on the Gisborne District Council website on 13 March 2023 (Appendix 5).
- 14. Copies of these notices have been perused, are accurate, and are held on file.

OBJECTIONS:

15. The District Licensing Committee Secretariat did not receive any objections to the application in accordance with Section 102 of the Sale and Supply of Alcohol Act 2012.

STATUTORY CRITERIA

THE OBJECT OF THE ACT:

- The sale, supply and consumption of alcohol should be undertaken safely and responsibly.
- The harm caused by the excessive or inappropriate consumption of alcohol should be minimised.
- 16. A substantial range of low-alcohol drinks are offered.
- 17. A substantial range of non-alcohol alternatives are also stocked. The applicant has regular specials on soft drinks.
- **18.** Bottled water will be freely available at the sample table during complimentary tastings.
- 19. Prohibited signage is displayed on the premises throughout the store.
- **20.** The applicant advises the premises do not engage in unacceptable promotions or irresponsible drinking practices.
- 21. During the renewal application I visited the premises on 23 March 2023 and found the premises compliant with requirements.
- 22. In my opinion, the applicant has provided adequate information and documentation to demonstrate that suitable measures will be undertaken to ensure the responsible sale and supply of alcohol, and that harm will be minimised.

THE MANNER IN WHICH THE APPLICANT HAS SOLD, DISPLAYED, ADVERTISED OR PROMOTED ALCOHOL:

- 23. The applicant is a part of the Super Liquor franchise that operates nationwide and has both a website and strong social media presence.
- 24. The Super Liquor website has a range of non-alcohol and low-alcohol options for purchase. Advertised alcohol specials show only a small discount applied. There were no issues identified to indicate unacceptable promotions of alcohol.
- **25.** During the renewal period the premises have been subject to the following monitoring and inspection activities:
 - 23 March 2023: No issues identified.
- **26.** During the renewal period the applicant has implemented the following measures to improve good order and amenity, the object of the act and alcohol related harm:
 - Increased their promotion of food/snack items, including extending their range of non-alcohol drinks available.
 - As part of the rebranding of the store the applicant has installed additional lighting that has brightened the store as well as additional CCTV cameras.
- 27. The applicant advises the premises do not engage in unacceptable promotions or irresponsible drinking practices and during the renewal period I have not become aware of any such practices. A check of the website showed no evidence of issues.

SUITABILITY OF THE APPLICANT:

- 28. The applicant is a private company, duly incorporated under the Companies Act 1993 on 2 December 2021 (reference no. 8268900) (Appendix 6).
- 29. The company has two directors, Barinderjeet Kaur and Sarabjeet Singh, both of Gisborne.
- 30. The shareholders of Sran Liquor Holdings Limited are:

- 31. There have been no changes to directors or shareholders during the renewal period.
- **32.** The company has operated the business since March 2022. This husband and wife team are residents of and business owners in the community.
- **33.** Both directors are holders of current Managers Certificates. They have owned Huxley Road Dairy since 2009 and Village Superette since 2016 and continue to operate these businesses.
- **34.** Barinderjeet Kaur is responsible for the overall management of the business. She is assisted by Daniel Beets and Wayne Koopu with the day to day running of the store.
- **35.** The premises has a robust host responsibility policy (Appendix 7), and this is prominently displayed on the premises on the right at the service counter.
- **36.** The applicant has not declared any convictions during the renewal period and the Police have not brought up any matters of suitability in their report.

- **37.** There have been no failed Controlled Purchase Operations (CPOs), enforcement actions, negative holdings or problems with noise or good order and amenity that have not been sufficiently addressed during the renewal period.
- **38.** Based on my discussions with the applicant, my inspection of the premises, the supplementary documentation accompanying the application, the reports filed, and the absence of any adverse issues during the renewal period, it is my opinion that the applicant is aware of their responsibilities under the Act and is suitable to operate the licensed premises.

DAYS AND HOURS DURING WHICH THE APPLICANT PROPOSES TO SELL ALCOHOL:

39. The applicant proposes to sell alcohol on the following days and during the following hours:

Monday to Sunday 9:00am to 9:00pm

- **40.** Normal trading hours for the business are 9:00am to 7:00pm Sunday Tuesday, and 9:00am to 8:50pm Wednesday Saturday. These trading hours are prominently displayed at the principal entrance (Appendix 8).
- **41.** There is no variation to existing hours of trade. In my opinion, the days and hours applied for are suitable for this type of premises.

GISBORNE DISTRICT LOCAL ALCOHOL POLICY (GDLAP):

42. The application complies with the maximum hours detailed in section 3.2 of the GDLAP for off licensed premises.

DESIGN AND LAYOUT OF THE PREMISES:

- **43.** The licensed premises are outlined in the plan received with the application (attached as Appendix 9).
- **44.** There have been no changes in the floor plan or the licensed area since the last renewal. The key features of the premises include:
 - The principal entrance accessed from Potae Avenue
 - The service counter to the left of the principal entrance
 - The walk-in beer chiller to the far right of the display area
 - The office to the far left of the licensed area
 - The staff room and amenities on the left through the door at the rear of the licensed area
 - The storeroom to the right of the staff areas. The storeroom extends into the "leg" at the end of the building and opens into the loading bay via roller doors.
- 45. The applicant has proposed to designate the licensed area as supervised.
- **46.** The applicant has provided a Crime Prevention Through Environmental Design (CPTED) assessment of the premises (Appendix 10) which demonstrates that the premises has, through the design and layout, minimised potential harm and ensured a safe environment for patrons.
- **47.** An inspection of the premises verified the CPTED assessment by the applicant, and there are no issues or concerns with regard to the design and layout of the premises.

48. It is my opinion that the design and layout of the premises is adequate to fulfil the object of the Act in terms of minimising potential harm and ensuring a safe environment for patrons, in conjunction with the applicant's operational procedures.

THE SALE OF GOODS AND THE PROVISION OF OTHER SERVICES:

- **49.** The applicant is engaged in the sale of goods or the provision of services other than those directly related to the sale of alcohol, low and non-alcoholic refreshments, and food.
- **50.** The applicant has merchandise available from shelving on the service counter and from an accessory stand across from the counter which includes stubby coolers.
- **51.** The applicant proposes to sell cigarettes and tobacco, which is deemed acceptable for the purposes of the proposed licence.
- **52.** In my opinion the sale of goods and provisions of other services is compatible with the sale of alcohol.

AMENITY AND GOOD ORDER OF THE LOCALITY:

Current and possible future levels of noise, nuisance, and vandalism:

- **53.** The Council has no record of any noise complaints or noise issues relating to the operation of on licence during the renewal period.
- **54.** The Council has no record (including Police reporting) of any existing nuisance and vandalism issues in the locality or during the renewal period.

Conclusion

55. Considering the above, in my opinion, the amenity and good order of the locality would not be likely to be increased, by more than a minor extent, by the effects of a refusal to renew the licence.

SYSTEMS, STAFF AND TRAINING:

- **56.** The applicant has provided the following management plans and supporting information:
- 57. The applicant has advised that four employees are certificated managers (Appendix 11):

58. This is sufficient for the intended days and hours of sale proposed under the licence.

- **59.** All staff involved in the sale and supply of alcohol are trained in the premises host responsibility policy, operational procedures and the requirements of the Act and the licence.
- **60.** Staff have regular internal training via Super Liquor Academy (Appendix 12). Refresher training is done at least every six months. All staff sign acknowledgment forms. The area manager visits several times a year to carry out an audit of training and procedural matters. A copy of the staff acknowledgment form was included with the application (Appendix 13).
- **61.** The duty manager and staff will be regularly circulating and monitoring the premises and patrons for compliance. The duty manager or senior staff are notified of any issues, but the duty manager makes the final call about any matters if any conflicts arise.
- **62.** ID checking is undertaken by staff for all persons who appear to be under 25 years of age. Staff are trained in recognising fake ID cards and if the person has been banned from the premises. This is also checked as part of the Super Liquor franchise audit process.
- 63. All staff are trained in identifying signs of intoxication using the SCAB model, and the intervention methods listed in the host responsibility policy and implementation plan. Alcohol will not be served to those customers that display signs of being observably adversely affected by alcohol. All persons considered intoxicated are removed and all incidents are recorded via an incident book.
- 64. The premises has a dress code restricting the wearing of sunglasses and hoods.
- 65. There is a policy in place to call Police and trespass offenders where required.
- **66.** After review of the application, supporting information and discussions with the applicant, in my opinion the applicant has demonstrated that there are appropriate systems, staff and training to meet the requirements of the Act.

REPORTS FROM OTHER AGENCIES:

- **67.** The NZ Police have inquired into the application, and do not oppose the granting of the licence. A copy of the report, dated 1 June 2023, is attached to the application.
- **68.** Fire and Emergency NZ (Tairawhiti) have commented on the application, in an email dated 17 March 2023, offering no matters in opposition.
- **69.** The reporting Officer for the Medical Officer of Health has not submitted a report within the 15 working day statutory timeframe prescribed under Section 103(3)(b) of the Act. It is therefore assumed, under Section 103(4) of the Act, that the Medical Officer of Health does not oppose the application.

RECOMMENDATION:

70. Having regard to the particulars of the application and the relevant statutory criteria under the Act(s), I do not oppose the application, and recommend that the licence be granted.

Cathy SCOTT and Georgie ROBERTSON of LicenceMe as Authorised Agents for Barinderjeet KAUR and Sarabjeet SINGH on behalf of Sran Liquor Holdings Limited for Super Liquor Lytton situated at 3 Potae Avenue, Gisborne.

The applicant in this matter seeks the renewal of the off-licence (Bottlestore).

The application as required by section 103 was forwarded to the Police for reporting on the 10th March 2023.

Police have considered section 131"Criteria for renewal".

The Super Liquor Lytton operates as a retail premises where at least 85% of the annual sales revenue is expected to be earned from the sale of alcohol for consumption elsewhere and complies with Section 32 (1)(b) being a kind of premises for which off-licence may be issued.

Police are seeking two conditions to be placed on the licence to ensure that necessary steps are taken to mitigate alcohol harm to benefit the community. These conditions are outlined below. With reference to "The Gisborne District Local Alcohol Policy";

Trading Hours: Monday to Sunday

from 09.00am to 09.00pm

The hours of operation fall within the Gisborne Local Alcohol Policy relating to Off-Licence premises being 07.00am to 09.00pm.

The Super Liquor Lytton is located with 150 metres of two sensitive sites being Lytton High School and the House of Breakthrough Tairawhiti Church.

Super Liquor Lytton is also situated in close proximity to Forrester House situated at 403 Ormond Road, being an accommodation facility providing short/long and emergency housing within the community.

The premises is located in a busy local shopping community where many young people and elderly frequent and spend significant time.

As a measure to mitigate alcohol exposure to the community and young persons Police suggest that the applicant abide by the following conditions and these conditions have been agreed to by the applicant.

Conditions:

External Advertising:

The Licensee must ensure that there is no external advertising of alcohol products and pricing on the external of the building.

Single Sales:

The licensee must ensure that there are to be no single sales of ready-to-drink beverages including mainstream beers, RTD's and shots (except in vessels over 500ml and craft beer).

Certified Managers:

The applicant has listed four certified managers, namely Barinderjeet KAUR (27/CERT/12945/2022), Sarabjeet SINGH (27/CERT/12976/2022), Wayne Samuel KOOPU (27/CERT/10274/2017) and Daniel Brett BEETS (27/CERT/11307/2019).

Licensed Area:

Police recommend the whole of the licensed area is designated Supervised.

Police do not oppose the application as the applicant agrees to the take reasonable steps to mitigate alcohol harm as discussed in this report being the External Advertising and Single Sales.
