OFF-LICENCE

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (The Act), S & P Private Limited (the licensee) is authorised to sell alcohol on the premises situated at 60 Pegasus Main Street Pegasus and known as Super Liquor Pegasus, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or man ers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours:

MONDAY to SUNDAY 10AM to 10PM

- (c) The whole of the premises is designated as a supervised area.
- (d) The premises are more precisely identified as outlined in the application received by the Waimakariri District Licensing Committee on 20 January 2023.
- (e) A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the Pegasus Main Street is designated as the principal entrance.
- (f) To not have any sandwich boards/flags on the footpath that advertise alcohol. This does not prevent the use of a flag or similar that says 'open'.
- (g) To not have any alcohol branded advertisements on the shop frontage.
- (h) To limit shop frontage advertising to 3 A3 non-branded posters that may include Super Liquor's weekly or monthly specials sheet.
- (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (j) No alcohol is to be sold to anyone wearing school uniform.
- (k) A Certificate of Public Use, or a Code Certificate of Compliance is achieved for the premises fitout; and The Licensing Inspector has inspected the premises and the fit out is as per parand no issues with the layout are found; and
- (I) The Licensing Inspector is to report to the immediately to the DLC after the above two provisions are met.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
