# OFF-LICENCE

#### Sections 17 and 64

Pursuant to the Sale and Supply of Alcohol Act (the Act), SSSD LIMITED (the licensee) is authorised to sell and supply alcohol, on the premises situated at 436 Prestons Road, Christchurch, and known as "SUPER LIQUOR PRESTON", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### CONDITIONS

- No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day. a)
- Alcohol may only be sold or delivered on the following days and during the following hours:

**1 MAY TO 31 OCTOBER** MONDAY TO SUNDAY 9.00 AM TO 9.00 PM **1 NOVEMBER TO 30 APRIL** MONDAY TO SUNDAY 9.00 AM TO 9.00 PM

- Water must be freely available to customers, while alcohol is being supplied free as a sample on the premises.
- The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are d) observed:
  - Display of appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons
- e) The following steps must be taken to ensure that the provisions of the Act relating to the management of the premises concerned are observed:
  - Alcohol must only be sold and supplied on the premises in accordance with the premises plan submitted with the application.
  - The licensee must implement and maintain the steps proposed in their host responsibility policy.
- The whole of the premises is designated as a supervised area.

## SECTION 117 - OTHER DISCRETIONARY CONDITIONS:

- The licensee must implement and maintain the steps proposed in The Super Liquor Prestons Responsibility Policy<sup>1</sup> aimed at promoting the reasonable consumption of alcohol.
- h) There shall be low alcohol and alcohol-free products prominently displayed to promote responsible consumption of alcohol.
- There will be no sales of single-serve RTDs (or Beers from broken cartons). i)
- No sales will be made to young persons in school uniform regardless of their ability to produce ID. i)
- There shall be no advertising of alcohol products attached to the exterior of, or visible from outside, the premises.
- No sandwich boards shall be used to advertise the premises or goods for sale. One flag may be used, dependant on the approval of 1) the Developer.
- m) There will be no sales of alcohol products packaged in plastic PET bottles over 1 litre that contain guarana or caffeine.
- Any alcohol sold by remote transaction after 7:00pm will not be delivered until after 6:00am the following day.

## OTHER RESTRICTIONS AND REQUIREMENTS TO BE NOTED ON THE LICENCE

Section 56 - Display of signs; Section 57 - Display of licences; Section 59 - Requirements relating to remote sales by holders of offlicences; Section 214 - Manager to be on duty at all times and responsible for compliance

### **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- either
  - until the close of the period for which it was last renewed; or
  - if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- if an application for the renewal of the licence is duly made before the licence would otherwise expire, either
  - until the close of the period of 3 years after the period for which it was last renewed; or

if it has never been renewed, until the close of the period of 4 years after the day it was issued.
